Incomplete forms will not be accepted.

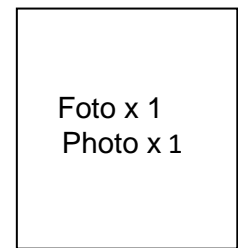

STATUTORY OBLIGATION TO PAY SCHOOL FEES

1. I /We hereby apply to have the Child whose name appears on the form, admitted as a learner at Knysna High School.
2. I /We hereby certify that I/We are the biological/adoptive parents and that I/We have legal custody and/or legal guardianship in respect of the said learner.
3. I/We take note and understand the following:
 - a. Compulsory annual school fees for 2022 amount to ±R16 400 and will be set at a general meeting of the parents later in the year.
 - b. School fees are payable in advance and are due on the first day of school.
 - c. The payment options are as follows:

Fees will be paid in the first week of a term	
Fees will be paid in 10 equal monthly instalments (in advance)	

- d. If school fees are paid in full on or before the 28 February 2022 then a 10% discount will be deducted from your annual school fees.
 - e. If parents are in arrear with any one instalment then the full amount becomes due and payable immediately.
 - f. A sum of ±R2 500 is payable before the end of October. This amount will be deducted from the R16 400 compulsory annual fees. Should the learner fail to attend the school, this fee will be refunded to the parent upon written request from the parent providing banking details for a refund.
 - g. If your child is accepted a further R475 will be payable towards an enrolment pack which includes a sport shirt, diary and tie. You will be reminded about this via SMS or the email that you provided.
 - h. Biological/adoptive parents are jointly and severally liable for the payment of school fees irrespective of their marital status.
 - i. In the event of non-payment of school fees the school will institute legal action against both parents irrespective of maintenance and court orders which may exist between the parties.
 - j. In terms of Section 39 of the South African Schools Act, parents are liable to pay compulsory school fees. This is a statutory obligation.
 - k. In terms of Section 40 and 41 of the South African Schools Act, the school may enforce the payment of these compulsory fees.
 - l. In the event of the school having to take legal action for the recovery of school fees, all legal costs, including attorney/client fees and collection costs incurred by the school will be charged to the parent's account.
 - m. I/We have been informed that if I/We are unable to pay school fees I/We may apply for exemption from these fees.
 - n. If Parent/s fail to meet their school fee obligations the school may record the Parent/s non-performance with a credit bureau.
4. I/We undertake to give notice in writing of any intention to remove my/our child from the school and furthermore to return any books and/or equipment belonging to the school which our child may have in his/her possession.
5. ***Unless you instruct the School expressly and in writing to the contrary, your consent is given for the School to:***
- i. collect, store and process information about you and any Third Party or divorced or separated Parent responsible for payment of any or all amounts owing in respect of school fees.***

- ii. **collect, store and process names, contact details and information relating to yourself and your Child, and consent to such information being made available to other parents/guardians, staff or responsible persons engaged or authorised by the School for School-related purposes to the extent required for promoting good relations between the School, parents/guardians, and current learners as well as providing references and communicating with former learners;**
